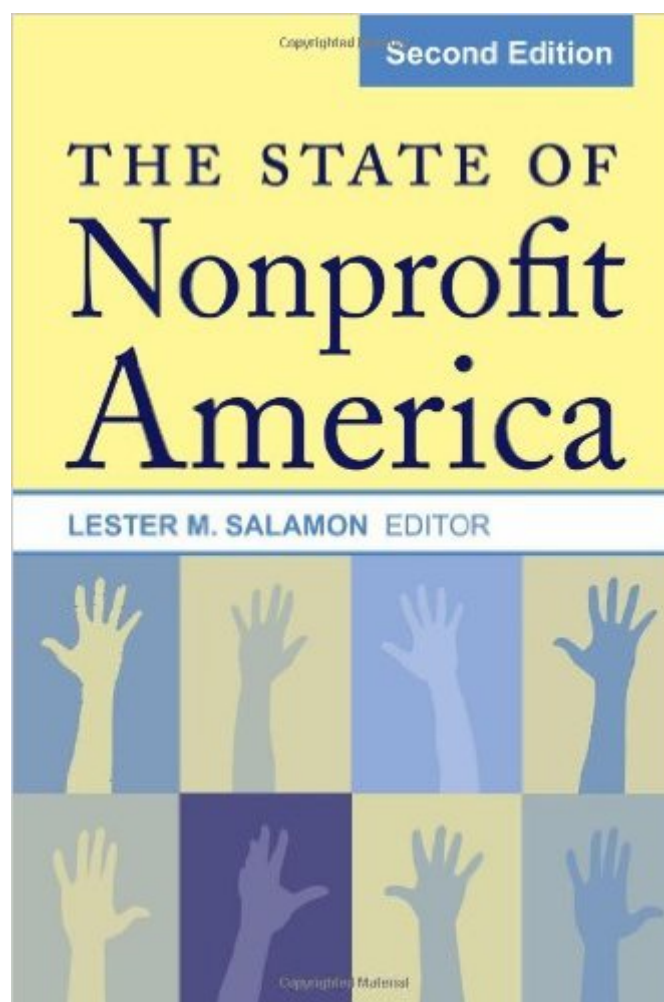

Synopsis
